

Item 2.02 Night work will be permitted for the project providing the County receives a written notice at least 48 hours prior to the start of work being performed. A permit will be required if any new wiring is to be installed and inspection will need to be performed at any location new wiring is installed. All permit fees will be waved and inspection will need to be coordinated with Washington County.

Item 2.03 Speed Limit through the bridge is 35 mph from each direction
