## **ELIGIBILITY REQUIREMENTS FOR TEMPORARY TIP JAR LICENSES**

In accordance with The Tip Jar Regulations of the Washington County Gaming Office, the following eligibility criteria must be met prior to a temporary tip jar license being issued:

The organization must be a bona fide charitable organization, and;

The funds raised must be for charitable, athletic, or educational purpose (which meets the requirements for a charitable contribution under Section 170(c) of the Internal Revenue Code, and;

**If the nature of your organization is athletic (softball, football, etc...), the funds raised cannot be used to purchase uniforms, other equipment, or facilities.**

The purpose may not be to benefit a law enforcement agency or law enforcement fraternal organization; a political club, committee or party; or an agency of the State Government or of a political subdivision of the State.

**You must report your tip jar sales to the Gaming Office within 10 days after the conclusion of your event. Failure to do so will result in a denial of any future license request, without exception.**

**NOTE: A temporary license may be issued for a period not to exceed nine (9) consecutive days. No more than four (4) licenses will be issued to an applicant during the twelve month period from July 1 through June 30, except upon a showing by the applicant of special circumstances which shall be determined by the Gaming Office.**
