BUS RULES

- 1) **WHEN BOARDING THE VEHICLE, PAY THE FARE IN EXACT CHANGE. ALL CARRY-ON PACKAGES MUST BE BROUGHT ON BUS IN A SINGLE ENTRY. CARRY-ON RESTRICTIONS APPLY.**
- 2) **“NO” SMOKING, EATING, DRINKING, CHEWING GUM, SEAT CHANGING, LOUD TALKING (INCLUDING CELL PHONES) OR OFFENSIVE LANGUAGE. SHOES AND SHIRTS ARE REQUIRED.**
- 3) **REFRAIN FROM PLAYING AUDIO (INCLUDING HEADSETS IF AUDIBLE TO OTHERS) AND ELECTRONIC GAME DEVICES.**
- 4) **ONLY SERVICE ANIMALS OR SMALL CAGED ANIMALS PERMITTED ON BOARD.**
- 5) **CHILDREN MUST BE KEPT UNDER CONTROL & SEATED AT ALL TIMES. CHILDREN UNDER 12 MUST BE ACCOMPANIED BY AN ADULT.**
- 6) **STROLLERS & SHOPPING CARTS MAY NOT BLOCK PASSENGER ACCESS.**
- 7) **BRING ON BOARD ONLY THOSE ITEMS WHICH WILL FIT ON YOUR LAP OR UNDER YOUR SEAT.**
- 8) **DISRUPTIVE BEHAVIOR, INTOXICATION OR HARASSMENT OF OTHERS WILL RESULT IN LOSS OF RIDING PRIVILEGES.**
- 9) **REMAIN SEATED UNTIL BUS HAS REACHED YOUR DESTINATION AND HAS FULLY STOPPED.**
- 10) **WAIT UNTIL THE BUS HAS STOPPED BEFORE ASKING THE DRIVER QUESTIONS. DRIVERS NEED TO DIRECT THEIR ATTENTION TO DRIVING WHILE THE BUS IS MOVING.**
- 11) **WE ARE NOT RESPONSIBLE FOR LOST ITEMS. FOUND ITEMS WILL BE TURNED IN TO THE OFFICE WHERE THEY MAY BE PICKED UP THE NEXT BUSINESS DAY.**
- 12) **SCHEDULED TIMES ARE APPROXIMATE. PLEASE BE AT DESIGNATED LOCATIONS FIVE (5) MINUTES BEFORE TIMES LISTED ON THE SCHEDULES.**
- 13) **BUS STOPS INCLUDE POSTED LOCATIONS AND MOST NAMED STREET CORNERS. EXCLUDED ARE LOCATIONS WITHIN TWO (2) BLOCKS PRIOR TO A LEFT TURN FROM A MULTI-LANE STREET OR WHERE THE DRIVER HAS OBSERVED A BUS STOP WOULD BE UNSAFE FOR PASSENGERS.**
- 14) **IF YOU QUALIFY FOR REDUCED FARE, YOU MAY BE REQUIRED TO PRESENT YOUR I.D. CARD IN ADVANCE.**
