(Award of a contract for line striping services ("Line Striping Services) for the Washington County Highway Department ("Highway Department") from Alpha Space Control Co., Inc. of Fayetteville, Pennsylvania, under an intergovernmental cooperative purchasing arrangement with the City of Hagerstown, Maryland, pursuant to Section 1-106.3 of the Code of the Public Local Laws of Washington County, Maryland)

RECITALS

The Code of the Public Local Laws of Washington County, Maryland (the "Public Local Laws"), §1-106.3, provides that the Board of County Commissioners of Washington County, Maryland (the "Board") "may procure goods and services through a contract entered into by another governmental entity in accordance with the terms of the contract, regardless of whether the county was a party to the original contract."

Subsection (c) of §1-106.3 provides that: "A determination to allow or participate in an intergovernmental cooperative purchasing arrangement under subsection (b) of this section shall be by resolution and shall either indicate that the participation will provide cost benefits to the county or result in administrative efficiencies and savings or provide other justifications for the arrangement."

Acquisition of the Line Striping Services by "piggy-backing" on a bid processed by the City of Hagerstown, Maryland and eliminating the Board's bid process would result in administrative efficiencies for both the Highway Department and the Purchasing Department. Using the City of Hagerstown, Maryland contract award, the Board will be able to acquire from Alpha Space Control Co., Inc. the Line Striping Services for a total price of \$65,309.40.

The Board expressly finds that entering into a contract with Alpha Space Control Co., Inc. to purchase the Line Striping Services would be in the best interests of the citizens of Washington County.

NOW, THEREFORE, BE IT RESOLVED by the Board, pursuant to §1-106.3, a contract is hereby awarded to Alpha Space Control Co., Inc. of Fayetteville,
