

RESOLUTION No. RS-07-017

(Purchase of one (1) F350 Super Duty Crew Cab Pickup Truck (the "Crew Cab Pickup Truck") for use by the Washington County Highway Department from Day Fleet Sales of Monroeville, PA under an intergovernmental cooperative purchasing arrangement with the City of Harrisburg, Pennsylvania (the "City of Harrisburg"), pursuant to Section 1-106.3 of the Code of the Public Local Laws of Washington County, Maryland)

RECITALS

The Code of the Public Local Laws of Washington County, Maryland (the "Public Local Laws"), §1-106.3, provides that the Board of County Commissioners of Washington County, Maryland (the "Board") "may procure goods and services through a contract entered into by another governmental entity in accordance with the terms of the contract, regardless of whether the county was a party to the original contract."

Subsection (c) of §1-106.3 provides that: "A determination to allow or participate in an intergovernmental cooperative purchasing arrangement under subsection (b) of this section shall be by resolution and shall either indicate that the participation will provide cost benefits to the county or result in administrative efficiencies and savings or provide other justifications for the arrangement."

Acquisition of the Crew Cab Pickup Truck by "piggy-backing" on a bid processed by the City of Harrisburg and eliminating the Board's bid process would result in administrative efficiencies and savings for both the Washington County Highway Department and the Washington County Purchasing Department. Using the City of Harrisburg's contract award as a basis for negotiation, the Board will be able to acquire the Crew Cab Pickup Truck from Day Fleet Sales for a total price of \$31,579.00.

The Board expressly finds that entering into a purchase agreement with Day Fleet Sales under an intergovernmental cooperative purchase arrangement with the City of Harrisburg to purchase the Crew Cab Pickup Truck would be in the best interests of the citizens of Washington County.


NOW, THEREFORE, BE IT RESOLVED, pursuant to §1-106.3, that the Board enter into a purchase agreement with Day Fleet Sales for the purchase of one (1) F350 Super Duty Crew Cab Pickup Truck under an intergovernmental cooperative

purchase arrangement with the City of Harrisburg, utilizing the City of Harrisburg's contract.




