RESOLUTION NO. RS-2016- 08

(Award of Oracle Cloud Products and Services (the "Oracle Cloud Services") for various using departments from Mythics, Inc. ("Mythics") of Virginia Beach, Virginia, under an intergovernmental cooperative purchasing arrangement with The Cooperative Purchasing Network ("TCPN"), pursuant to Section 1-106.3 of the Code of the Public Local Laws of Washington County, Maryland)

RECITALS

The Code of the Public Local Laws of Washington County, Maryland (the "Public Local Laws"), \$1-106.3, provides that the Board of County Commissioners of Washington County, Maryland (the "Board") "may procure goods and services through a contract entered into by another governmental entity in accordance with the terms of the contract, regardless of whether the county was a party to the original contract."

Subsection (c) of §1-106.3 provides that: "A determination to allow or participate in an intergovernmental cooperative purchasing arrangement under subsection (b) of this section shall be by resolution and shall either indicate that the participation will provide cost benefits to the county or result in administrative efficiencies and savings or provide other justifications for the arrangement."

Acquisition of the System by "piggy-backing" on a bid processed by TCPN, and eliminating the Board's bid process would result in administrative efficiencies for Washington County. Using the TCPN's contract #TCPN R141801, the Board will be able to acquire from Mythics the Oracle Cloud Services for the total sum of Three Hundred Twenty-One Thousand Five Hundred Sixty-Four Dollars and Thirty Cents (\$321,564.30).

The Board expressly finds that entering into a contract with TCPN, to purchase the Oracle Cloud Services would be in the best interest of the citizens of Washington County.

NOW, THEREFORE, BE IT RESOLVED by the Board, pursuant to \$1-106.3 of the Code of the Public Local Laws of Washington County, Maryland, a contract is hereby awarded to Mythics, Inc. of Virginia Beach, Virginia, for the purchase of Oracle Cloud Products and Services for various using departments under an intergovernmental cooperative purchase of services arrangement with The Cooperative Purchasing Network.
