RECOMMENDED MOTION: Move to approve the 10-year Agricultural Land Preservation Districts for the following twenty-four (24) property owners: Hays, Black, Talton, Kefauver, Bryce, Rowe, Worthington, Horst, Divel, Martin, Gruber, Berry, Deater, Edgemont Orchards Partnership, Shank, Sheffler, Bragunier Farms, Inc., Bragunier, Davis, Divelbiss, and Blanks.

REPORT-IN-BRIEF: Establishing an Agricultural Land Preservation District demonstrates each landowner's commitment to use the property for only agricultural purposes through a recorded District Agreement for a minimum of ten years. Landowners may elect to terminate or continue the District after 10 years (or after 5 years, per ORD-2018-20). District establishment is also the first step towards eligibility to sell a permanent agricultural preservation easement. Basic information for each applicant can be found on the attached list. Each application has met the criteria of being a minimum of 50 acres in size (or a minimum of 20 acres if contiguous to another district or permanent easement), 50% Class 1, 2 or 3 soils (unless an extraordinary use) and outside areas programmed for public water and sewer.

DISCUSSION: In exchange for the landowners' commitment to use their property for agricultural purposes only, they will receive County property tax credits on their agricultural land and buildings and a credit of up to \$696 on their dwelling. The District/Credit program was adopted at the County level in 1991 and was updated in 2018 by ORD-2018-20 and ORD-2018-21. The purpose of the public hearing is to take public comment from interested parties.

FISCAL IMPACT: The cost of tax credits for these properties for the full ten-year period is approximately \$12/acre/year for a total of about \$33,864 per year. This will be in the form of property taxes not collected. A total of 2,822 acres will be included in the twenty-four (24) Districts.

CONCURRENCES: The Agricultural Land Preservation Advisory Board approved all of the Districts because they meet program criteria for size, soils, and assessment. The Planning Commission/Planning Staff have determined the properties are consistent with Comprehensive Plan requirements due to their locations outside of County-designated growth areas and planned water and sewer service areas.

ALTERNATIVES: Deny any or all of the pending 10-year Districts.

REPORT-IN-BRIEF: On May 7, 2024, the Board of County Commissioners held a public hearing regarding the proposed increase in current charges, rentals, and fees at the Hagerstown Regional Airport. Being presented today is a modified schedule of rates and charges based on feedback received during the public hearing and associated budget changes.

DISCUSSION: The schedule of rates and charges has been modified to remove the proposed fees for common dumpster costs and the other miscellaneous fees except for terminal ground parking fees. The 4% increase in T-Hangar rental charges is still being proposed. This modification resulted in a reduction in Reimbursed Expense revenue and an increase in the use of Fund Balance Reserve in the amount of \$38,000. The total budget for the Airport remains unchanged at \$3,715,420.

The Airport fund is self-supported and does not require a general fund subsidy for FY25.

REPORT-IN-BRIEF: The State Homeland Security Grant program is administered by the Federal Emergency Management Agency and passes through the Maryland Department of Emergency Management to be distributed to local jurisdictions. The program is intended to enhance and maintain current Homeland Security initiatives as they pertain to prevention, preparedness, response, recovery, and mitigation. The grant will pay a partial salary for the Emergency Management Specialist, the cost of the Washington County Citizen Notification software annual fees, a part-time position within the Washington County Sheriff's Office for Incident Management Team coordination and projects, and other costs, which include training, equipment, and response capabilities.

DISCUSSION: The Office of Grant Management has reviewed the grant guidelines. The performance period for this federal grant is September 1, 2024, through August 31, 2027. There is no matching fund requirement associated with this grant; however, at least 35% of the grant funds must be spent on law enforcement-related tasks or equipment.

SUBJECT: CVS programs to assist Washington County Employees.

PRESENTATION DATE: May 14, 2024

PRESENTATION BY: Chip Rose, HR Director; Jason Miller, Benefits Coordinator

RECOMMENDED MOTION: Awareness & Support of the programs.

REPORT-IN-BRIEF: Drug manufacturers are marketing brand named drugs so well, employees are requesting prescriptions for designer drugs, unaware of the alternatives. In some instances (Humira) there are significantly more affordable prescriptions available and in other cases (Ozempic) patients are seeking prescriptions to treat conditions other than what it was approved for by the FDA.

DISCUSSION:

Program 1: CVS **Pro-logic initiative.** Ozempic was approved by the FDA to treat diabetes. It works by binding receptors and stimulating insulin release from the pancreas. As a side effect, many patients lose weight while on the medication. So much so, tens of thousands of prescriptions have been issued to patients without diabetes, presumably for weight loss. The FDA has warned the medical risks for non-diabetic patients are significant. The pro-logic initiative will deny new prescriptions for employees without a history of diabetes and require a physician's approval (PA) to confirm the diagnosis of diabetes. We currently do not approve any weight loss drugs through our formulary.

Program 2: CVS Biosimilar program. Humira was approved by the FDA to treat a broad spectrum of inflammatory diseases like rheumatoid arthritis and other serious illnesses like Crohn's disease. AbbVie announced Humira was the country's top selling drug in 2023 year (\$20B) and their raising prices 8% in 2024. There are nine (9) BIOSIMILAR drugs (nearly identical active ingredients) that cost 15-20% of Humira, but they lack the marketing engine of AbbVie. CVS will recommend biosimilar drugs to any new Humira prescription. Again, CVS will require a PA to either confirm the Humira Rx or one of the biosimilars.

FISCAL IMPACT: Two examples: When compared to the average retail price of Humira (~\$7,000/month); Cyltezo is 79% cheaper and Hulio is 83% cheaper (sources: Prudent Rx & Good Rx).

REPORT-IN-BRIEF: The equipment will be installed in and on vehicles that were approved by the Board in January 2024.

DISCUSSION: The Code of the Public Local Laws states that a contract over \$50,000 for the purchase or other expenditure shall be awarded by the Board to the lowest responsible bidder who submits a responsive bid. Request for Quotations are processed for purchases of commodities and services not exceeding \$50,000 and are normally awarded at the departmental level in concurrence with the Purchasing Department. Due to the recommendation of award the cost for the cameras/installation exceeded \$50,000, the Quotation is before the Board for an award. It was anticipated that these services would not exceed \$50,000.

It was anticipated these services would be quoted below the \$50,000 threshold which would not have required using the Invitation to Bid (ITB) advertisement process. As such, the Request for Quotation process was followed and not the formal bid process. As noted previously, a significant number of vendors reviewed the document; as such we do not believe publicly advertising the project in the newspaper or through the State's web site would have yielded any difference in the final outcome. Given the value of the quotations, the Board of County Commissioners' approval is necessary to award the purchase of the equipment.

FISCAL IMPACT: Funds in the amount of \$782,991 are available in the department's account 30-11310-VEH006 for this purchase.

RECOMMENDED MOTION: Move to award a "primary" requirements contract for Oracle Fusion Consultant Services for use by Budget & Finance, Human Resources and Information Systems (IS) Department to the responsive, responsible proposal with the lowest price proposal at the specified unit cost and estimated hours (no minimum or maximum guaranteed); and, as permitted in the Request for Proposal (RFP), a "stand-by list" of consultants at their specified unit costs and estimated hours (no minimum or maximum guaranteed).

REPORT-IN-BRIEF: The services under this contract consist of providing experienced public sector consultant services to assist Washington County functional and technical staff with planning, prioritization, and implementation of new or existing functionality, budgeting, financials, purchasing, transactional business intelligence, project financials, self-service procurement, human capital management base, payroll and time/labor on an as-needed basis. The duration of the contract shall be for a period of two (2) years, with an option by the County to renew for up to three (3) additional one (1) year periods. This is a requirements contract; therefore, services will be utilized on an as-needed basis at the respective hourly unit prices for each discipline with no guarantee of a maximum or minimum number of hours.

Project assignments will be issued in two (2) distinct manners through this contract. Assignments with a fee less than or equal to \$50,000 will be awarded to the designated responsive-responsible Consultant with the lowest price proposal: Metaformers, Inc. Assignments with fees anticipated to exceed \$50,000 will have a defined scope of work specified and distributed to those consultants deemed most qualified and offered to all consultants on the stand-by list. All consultants then will submit a proposal to complete the work defined. The consultants with the lowest cost proposal will then be given the assignment. The County has limited the stand-by list to a maximum of three (3) firms, one (1) of which is the designated responsive-responsible Consultant with the lowest overall price proposal. Assignment value will be determined when the Consultant applies the necessary man-hours and his standard rates to the individual assignment. The assignment will be given to the Consultant which requires the lowest fee.

In order to determine which proposal offered the overall lowest cost to the County for this recommended contract award; each proposer submitted hourly rates for various employee classifications or positions. The lowest cost proposal was determined by applying the quoted rates to

a position matrix that identified an approximate number of hours by position the County may possibly utilize over the next five (five) years.

Notice of the RFP was advertised on the County's web site with access to downloading the RFP and on the State's "eMaryland Marketplace" web site, and in the local newspaper. The document was accessed on-line seventy-four (74) times, and sixteen (16) firms were represented at the pre-proposal conference. Seven (7) firms responded with proposals. After evaluation of the remaining Qualifications & Experience submittals, two (2) firms were considered responsive, and their Price Proposals were opened and evaluated (see attached Price Proposal Tabulation Sheet).

The Coordinating Committee was comprised of the following members: Chief Financial Officer (Committee Chairman Designee), Director of Purchasing, the Information Systems Director, Director of Budget and Finance, the Information Systems Deputy Director – Software Support & Training, Human & Health Deputy Director, Accounting Supervisor, Software Support Analyst and Deputy Director of Budget & Finance.





Percentage of Choices


What was your primary purpose(s) for participating in the Career Expo? Select all that apply 26 Responses






What type of position are you seeking to hire? Select all that apply 22 Responses








Approximately how many jobs seekers did you meet at the event? 26 Responses




Approximately how many applications did you solicit at the event?
