- 4. Wineries, breweries, and distilleries need TAM certificate for at least one employee present at the event.
- 5. For wineries, breweries and distilleries please complete your offpermit sales license using our Washington County Liquor License number 20201888.

Please return completed forms by January 10, 2025. Your information will be used in promotional material, advertising and media so turn in all the completed forms ASAP to promote your business.
