- Design and deploy Remote Desktop Services (RDS) solutions for remote access and application delivery.
- Collaborate with cross-functional teams to assess infrastructure requirements and recommend appropriate solutions.
- Develop and maintain documentation for system configurations, procedures, and best practices.
- Troubleshoot complex technical issues related to network, server, and cloud infrastructure.
- Oversee physical infrastructure installations and ensure compliance with industry standards (cabling, mounting hardware...etc).
