# <u>ITEM 1.03</u> <u>ADDITIONAL INFORMATION/CLARIFICATIONS</u>: shall be incorporated into the Bid Documents.

- 1. <u>Items 3025 thru 3029</u>: Filterra inlets are shown on the plans. An approved equal Infiltration Inlet will be permitted so long as the inlets provide the same or better treatment and fit within the same footprint.
- 2. <u>Item 2001</u>: The vertical face cut wall between Station 44+20 to 46+20, right is expected to be a solid rock face. If this is not attainable, alternatives will be considered in Phase II of construction. The chain link fence (Item 6004) is to be installed at the top of this cut along the right of way line.

- 6. <u>Items 4015 thru 4018</u>: Where pipe collars are part of the retaining wall, they shall be incidental to that retaining wall.
- 7. <u>Item 4020</u>: Utility conduit is excluded from Item 4020- Utility Supports on Structures. Conduit is not included in this contract.

- Wire mesh Panels: Banker Wire L-178, 1.5" opening, 0.135 gauge Brushed Aluminum Finish for railings and benches.






