Include plans, shop drawings, hydraulic calculations, manufacturer's specifications, cut sheets, and/or detailed design reports, as applicable. Fire alarm submittals shall include battery calculations, a riser diagram, a symbol legend, and, if utilizing ceiling-mounted strobes, the corresponding ceiling heights and a reflected ceiling plan.							
Permit Conditions							
<ol style="list-style-type: none">1. Approved plans, with comments, must be retained on the job until the final inspection has been made. No building shall be occupied until all required final and occupancy inspections have been made where applicable. No inspection will be made without the approved plans on the job site. No work covered by this application may be performed before the permit issuance.2. Any deviation from the approved plans must be authorized by the approval of revised plans subject to the same procedure established for the examination of the original plans. This revision approval must be obtained prior to The proposed changes being made in the field.3. All sprinkler work must be performed by a contractor with a valid Maryland Sprinkler Contractor License.4. Permits become invalid if installation work is not started within six months from the date the permit is issued. If work does not continue to progress, the permit will become invalid six months after the last inspection is made.
