

DIVISION OF PERMITS AND INSPECTIONS

FLOODPLAIN PERMIT APPLICATION GUIDANCE

<u>Application Method</u>: The attached form may be used to apply for a County Floodplain Permit by mailing the application form, fee, drawing, and any other required information to the Permitting Office.

Application Fee: \$35.00 (Make check payable to: Washington County Treasurer). A separate \$150.00 fee may be assessed for technical review of projects requiring engineering analysis (hydrology & hydraulics) at the discretion of the Division of Engineering.

Drawings: All permit applications must have a standard scale drawing which shows:

- Dimensions of site;
- Size and location of existing and proposed structures or alterations;
- Setbacks;
- Elevation contours in mean sea level (NGVD);
- Delineation of the 100-year flood elevation and boundary; and
- Proposed elevation of the lowest floor and method of elevation, if applicable.

A County-approved Site Plan or Grading Plan may be submitted in lieu of the separate drawing described above.

Maryland Department of the Environment Permits: In addition to the County Floodplain Permit, an approval from the Maryland Department of Environment, Water Resources Administration may be required. Visit the MDE website at www.mde.state.md.us/programs/WetlandsandWaterways/ or call (410) 537-3768 for more information. A Washington County Floodplain Permit will not be issued until authorization is received from MDE for those projects requiring a Non-Tidal Wetland and Waterway Permit.

<u>Additional Provisions</u>: Additional provisions may apply. All work shall be done in accordance with the latest adopted edition of the Washington County Floodplain Management Ordinance.

Inspection: All work shall be subject to inspection by the Washington County Division of Permits and Inspections.
