(Indoor dining allowed at 50% capacity)

(Not to exceed 50% occupancy)

RETAIL ESTABLISHMENTS/BUSINESSES SELLING GOODS

(Not to exceed 50% occupancy)

- Bookstores • Car washes • Clothing & shoe stores
- Florists • Furniture stores • Jewelers
- Lawn & garden stores • Pawn shops • Pet groomers
- Sporting good stores • Tobacco & vape shops

NON-ESSENTIAL BUSINESSES

- Manufacturing • Construction • Specialty vendors
- Large and small retail shops • Wholesalers • Offices
- Travel agencies • Auto dealer showrooms
- Bank Branches

BEAUTY SALONS, BARBER SHOPS & ADDITIONAL PERSONAL SERVICES

(Not to exceed 50% occupancy & by appointment only)

- Hair Salons • Barber shops • Nail Salons
- Massage therapists • Tanning salons • Tattoo parlors

MOTOR VEHICLE ADMINISTRATION

(Select branches, limited basis by appointment only)

OUTDOOR RECREATION

- Golf courses & driving range • Outdoor archery & shooting ranges • Marinas & watercraft rental businesses
- Campgrounds • Horse boarding & riding facilities
- County parks and dog parks • Sports fields and courts
- Drive-in movie theaters • Outdoor swimming pools
- Outdoor day camps • Tour boats • Graduation ceremonies • Amusements & rides • Parades, festivals, fundraisers • Outdoor concerts (no audiences) • Outdoor sports gatherings and events (not open to general public)

FITNESS CENTERS & INDOOR POOLS

(Not to exceed 50% occupancy)

- Gyms • Martial arts facilities • Dance studios
- Aquatic facilities

SHOPPING MALLS

(Not to exceed 50% occupancy)

- Indoor malls • Arcades • Casinos

BINGO HALLS, BOWLING ALLEYS, POOL HALLS

(Not to exceed 50% occupancy)

- Bingo halls • Pool halls • Bowling alleys • Skating rinks
- Social and fraternal clubs

YOUTH SPORTS & SUMMER SCHOOL ACTIVITIES

- Summer school activities (limit 10-15 per room)
- Outdoor high school sports can practice (10 students per group) • Indoor youth and amateur sports (not open to general public. Cannot exceed 50% occupancy)

CONVENTION EVENTS

(Not to exceed 50% occupancy)

INDOOR CONCERTS, SHOWS, PERFORMANCES

(Can resume performances and customary operations, but no audiences)
