To Bidders:

This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Proposal Form. This Addendum consists of three (3) pages and one (1) attachment.

<u>NOTE</u>: All Bidders must enter the County Administration Building through either the front entrance at 100 West Washington Street or through the rear entrance (w/blue canopy roof) which is handicap accessible. Bidders must also use the elevator to access the Purchasing Department for submitting their bid. Alternate routes are controlled by a door access system.

ITEM NO. 1: <u>Inquiry</u>: Bid Item #8 - Sodium Hypochlorite Bulk - Conococheague WWTP – What is their normal delivery size?

<u>Response</u>: Refer to the bid document, Page 25, Detailed Technical Specifications, Item #8 – Sodium Hypochlorite Bulk; **DELETE** this item in its entirety.

ITEM NO. 2 <u>Inquiry</u>: Bid Item #12 - Calcium Chloride Flake – Hagerstown Pool – What is their normal delivery size?

<u>Response</u>: Refer to the bid document, Page 27, Detailed Technical Specifications, Item #12 - Calcium Chloride; **DELETE** this item in its entirety.

ITEM NO. 3: <u>Inquiry</u>: Bid Item #14 - Granular Activated Carbon - Conococheague WWTP - What is their normal delivery size?

Response: Normal delivery is approximately 2,500 pounds (fifty [50] 50-pound bags). Refer to the bid document, Page 28, Detailed Technical Specifications, Item #14 – Granular Activated Carbon; **CHANGE** the estimated annual usage to read **2,500 pounds**.

ITEM NO. 4 <u>Inquiry</u>: Bid Item #20 - Granular Calcium Hypochlorite – Conococheague WWTP – What is their normal delivery size?

<u>Response</u>: Normal delivery is approximately ten (10) 100-pound containers. Refer to the bid document, Page 31, Detailed Technical Specifications, Item #20 – Granular Calcium Hypochlorite; **CHANGE** the estimate annual usage to read (10) 100–Pound Containers.

ITEM NO. 5: <u>Inquiry</u>: Bid Item #23 - Sodium Hypochlorite – Marty Snook Pool – What is their normal delivery size?

<u>Response</u>: The normal quantity delivered for Martin L. Snook Pool is approximately seven (7) drums per delivery.

ITEM NO. 6: <u>Inquiry</u>: Bid Item #26 - Muriatic Acid – Marty Snook Pool – What is their normal delivery size?

<u>Response</u>: Refer to the bid document, Page 34, Detailed Technical Specifications, Item #26 - Muriatic Acid; **DELETE** this item in its entirety.

ITEM NO. 7: <u>Inquiry</u>: Bid Item #27 - Sodium Bisulfite – RC Wilson WTP – What is their normal delivery size?

<u>Response</u>: The City of Hagerstown receives this in one (1) 600-gallon tote shipment three (3) to four (4) times a year.

ITEM NO. 8: <u>Inquiry</u>: Bid Item #28 - Delpac 2020 – Winebrenner & Sharpsburg Plants – What is their normal delivery size?

<u>Response</u>: Normal delivery is approximately three (3) to five (5) 55-gallon drums per delivery for each location.

Refer to the bid document, Page 34, Detailed Technical Specifications, Item #28 - Delpac 2020; **CHANGE** the delivery section to read as follows: Delivery to Washington County Department of Water Quality Sharpsburg Water Plant, 17070 Shepherdstown Pike, Sharpsburg, MD 21782.

ITEM NO. 9: <u>Inquiry</u>: Bid Item #39 - Micro C 2000 - Winebrenner WWTP - What is their normal delivery size?

Response: Normal delivery of Micro C 2000 is one (1) 240-gallon tote per delivery.

Please assist in correcting this conflict.

<u>Response</u>: Correction to Addendum No. 1: The Unit of Measure for Item #40, Polymer Zetag 8814, shall be gallon bulk. The delivered price shall be per gallon. Please see the attached *Revised* Form of Proposal.
