RESOLUTION NO. RS-2017-04

(Award of a contract for the purchase and installation of eighteen (18) cameras, all related hardware and software of the Virtual Perimeter Monitoring System (VPMS), along with upgrading the terminal access control systems (the "System") for the Hagerstown Regional Airport from Skyline Technology Solutions ("Skyline") of Glen Burnie, Maryland, under an intergovernmental cooperative purchasing arrangement with Carroll County Government, pursuant to Section 1-106.3 of the Code of the Public Local Laws of Washington County, Maryland)

RECITALS

The Code of the Public Local Laws of Washington County, Maryland (the "Public Local Laws"), \$1-106.3, provides that the Board of County Commissioners of Washington County, Maryland (the "Board") "may procure goods and services through a contract entered into by another governmental entity in accordance with the terms of the contract, regardless of whether the county was a party to the original contract."

Subsection (c) of §1-106.3 provides that: "A determination to allow or participate in an intergovernmental cooperative purchasing arrangement under subsection (b) of this section shall be by resolution and shall either indicate that the participation will provide cost benefits to the county or result in administrative efficiencies and savings or provide other justifications for the arrangement."

Acquisition of the System by "piggy-backing" on a bid processed by Carroll Government, and eliminating the Board's bid process would result in administrative efficiencies for Washington County. Using the Carroll County Government's contract (Bid No. 49-F-2-13/14), the Board will be able to acquire from Skyline the System for the total sum of One Hundred Twenty-Three Thousand One Hundred Thirty-Nine Dollars and Thirty-Three Cents (\$123,139.33).

The Board expressly finds that entering into a contract with Skyline, to purchase the System would be in the best interest of the citizens of Washington County.

NOW, THEREFORE, BE IT RESOLVED by the Board, pursuant to \$1-106.3 of the Code of the Public Local Laws of Washington County, Maryland, a contract is hereby awarded to Skyline Technology Solutions of Glen Burnie, Maryland, for the purchase and installation of eighteen (18) cameras, all related hardware and software of the Virtual Perimeter Monitoring System (VPMS), along with upgrading the terminal access control systems under an intergovernmental cooperative purchase of services arrangement with Carroll County Government.
