RESOLUTION NO. RS-2018-01

(Award of a contract for the purchase and installation of twenty-two (22) On-Vehicle Video Surveillance Systems (the "Systems"), for the Washington County Transit Department from IVS, Inc., dba Angle Trax, of Dothan, Alabama, under an intergovernmental cooperative purchasing arrangement with Harford County Department of Procurement of Bel Air, Maryland, pursuant to Section 1-106.3 of the Code of the Public Local Laws of Washington County, Maryland)

RECITALS

The Code of the Public Local Laws of Washington County, Maryland (the "Public Local Laws"), §1-106.3, provides that the Board of County Commissioners of Washington County, Maryland (the "Board") "may procure goods and services through a contract entered into by another governmental entity in accordance with the terms of the contract, regardless of whether the county was a party to the original contract."

Subsection (c) of §1-106.3 provides that: "A determination to allow or participate in an intergovernmental cooperative purchasing arrangement under subsection (b) of this section shall be by resolution and shall either indicate that the participation will provide cost benefits to the county or result in administrative efficiencies and savings or provide other justifications for the arrangement."

Purchase of the Systems by "piggy-backing" on a bid processed by Harford County Department of Procurement, and eliminating the Board's bid process would result in administrative efficiencies for Washington County. Using the Harford County Department of Procurement contract (RFP No. 17-137), the Board will be able to purchase from IVS, Inc., dba Angle Trax, the Systems for a sum of Eighty-Three Thousand, Five Hundred Seventy-Nine Dollars and Fifty-Four Cents (\$83,579.54).

The Board expressly finds that entering into a contract with IVS, Inc., dba Angle Trax, to purchase the Systems would be in the best interest of the citizens of Washington County.

NOW, THEREFORE, BE IT RESOLVED by the Board, pursuant to \$1-106.3 of the Code of the Public Local Laws of Washington County, Maryland, a contract is hereby awarded to IVS, Inc., dba Angle Trax, of Dothan, Alabama, for the purchase and installation of twenty-two (22) On-Vehicle Video Surveillance Systems under an intergovernmental cooperative purchase of services arrangement with Harford County Department of Procurement.
