

RESOLUTION NO. RS-2020-07

(Intergovernmental Cooperative Purchase [INTG-20-0031] One [1] New 2020 Ford Super Duty F-550 [X5H] XL 4WD Super Cab Truck)

RECITALS

The Code of the Public Local Laws of Washington County, Maryland (the "Public Local Laws"), §1-106.3, provides that the Board of County Commissioners of Washington County, Maryland (the "Board"), "may procure goods and services through a contract entered into by another governmental entity in accordance with the terms of the contract, regardless of whether the county was a party to the original contract."

Subsection (c) of §1-106.3 provides that "A determination to allow or participate in an intergovernmental cooperative purchasing arrangement under subsection (b) of this section shall be by resolution and shall either indicate that the participation will provide cost benefits to the county or result in administrative efficiencies and savings or provide other justifications for the arrangement."

The Washington County Department of Water Quality looks to purchase one (1) New/Unused 2020 Ford Super Duty F-550 DRW (X5H) XL 4WD Super Cab 192" WB 84" CA, with a Reading Classic II Enclosed Body and Equipment, from 72 Hour, LLC, dba National Auto Fleet Group of Watsonville, California, at a cost of \$69,178.00. The Department would do so by utilizing another jurisdiction's contract, Sourcewell contract number 120716-NAF (formally known as NJPA, National Joint Powers Association) that was awarded by Sourcewell for the period of January 17, 2017, through January 17, 2021, with an option to renew up to one (1) additional one (1) year term.

The Board has determined that the County will benefit with direct cost savings in the purchase of this vehicle because of the economies of scale this contract has leveraged. Acquisition of this vehicle by utilizing the Sourcewell contract and eliminating the County's bid process will result in administrative efficiencies and cost savings for the Washington County Department of Water Quality and Purchasing Department. Any bid received as a result of an independent County solicitation would exceed the spend savings that Sourcewell's contract provides.

NOW, THEREFORE, BE IT RESOLVED by the Board, pursuant to §1-106.3 of the Public Local Laws, to approve the purchase of one (1) New/Unused 2020 Ford Super Duty F-550 DRW (X5H) XL 4WD Super Cab 192" WB 84" CA, with a Reading Classic II Enclosed Body and Equipment, from 72 Hour, LLC, dba National Auto Fleet Group of Watsonville, California, at a cost of \$69,178.00. The Department would do so by utilizing another jurisdiction's contract, Sourcewell contract number 120716-NAF (formally known as NJPA, National Joint Powers Association) that was awarded by Sourcewell for the period of January 17, 2017, through January 17, 2021, with an option to renew up to one (1) additional one (1) year term.

Adopted and effective this sixteenth day of April, 2020.


