## **RESOLUTION NO. RS-2025-15**

(Intergovernmental Cooperative Purchase [INTG-25-0180] Police Vehicle Equipment for the Washington County Sheriff's Office Price Increase)

## **RECITALS**

The Code of Public Local Laws of Washington County, Maryland (the "Public Local Laws"), § 1-106.3, provides that the Board of County Commissioners of Washington County, Maryland (the "Board"), "may procure goods and services through a contract entered into by another governmental entity in accordance with the terms of the contract, regardless of whether the county was a party to the original contract."

Subsection (c) of § 1-106.3 provides that "A determination to allow or participate in an intergovernmental cooperative purchasing arrangement under subsection (b) of this section shall be by resolution and shall either indicate that the participation will provide cost benefits to the county or result in administrative efficiencies and savings or provide other justifications for the arrangement."

The Washington County Sheriff's Office was approved April 29, 2025, to purchase Police Vehicle Equipment for the upfitting of sixteen (16) 2025 Ford Police Interceptors at the total price of \$57,696.00 from Troy Products of Montebello, California. However, due to an error in shipping cost calculations, this total price is inaccurate.

Therefore, the Washington County Sheriff's Office seeks to purchase Police Vehicle Equipment for the upfitting of sixteen (16) 2025 Ford Police Interceptors, to the responsible, responsive bidder Troy Products, of Montebello, California, at the total price of \$60,456, to utilize another jurisdictions' contract (#001B4600402) that was awarded by State of Maryland Department of General Services, and to repeal RS-2025-05, dated March 18, 2025.

Eliminating the County's bid process will result in administrative and cost savings for the County. The County will benefit with direct cost savings because of the economies of scale the aforementioned contract has leveraged. Additionally, the County will realize administrative efficiencies and savings as a result of not preparing, soliciting, and evaluating bids.

NOW, THEREFORE, BE IT RESOLVED by the Board, pursuant to § 1-106.3 of the Public Local Laws, that Resolution 2025-05, dated March 18, 2025, is hereby repealed, and the Washington County Sheriff's Office is hereby authorized to purchase Police Vehicle Equipment for the upfitting of sixteen (16) 2025 Ford Police Interceptors, to the responsible, responsive bidder

Troy Products, of Montebello, California, at the total price of \$60,456, and to utilize another jurisdictions' contract (#001B4600402) that was awarded by State of Maryland Department of General Services.
