**The Outbound scale closes at 3:15. Vehicles must be unloaded and on the outbound scales by 3:15p.m.**

**Permit holders may dump trash until 3:30 p.m.**

Effective: July 1, 2020

### **Residential Permit Fees**

Permits sales at the Forty West Landfill are cash or check  
Permit sales at the Convenience Centers are check only

For Disposal of Waste and Recycling from Permit Holder's Residence ONLY!

All Permits Available Individually

All Permits are valid from July 1 to July 1 (following year)

### **Residential Trash Permit**

Citizen \$130

Second Permit, Same Owner \$65

Senior Citizen age 62 or over \$95

Service-Related Disabled Veterans \$95

(Regular/Senior/DAV permits purchased after January 1<sup>st</sup> will be half price)

### **Residential Yard Debris Permit**

Yard Debris Permit with purchase of Residential Permit \$20

(must be purchased at the same time),

Stand Alone Yard Debris Permit \$25

### **Residential Recycling Permit**

Recycling Permit \$36

(Recycling Permit needed for use of Recycle bins and Cardboard Bins at all facilities)

### **Commercial Solid Waste Collection License**

Less than 5 employees \$10

Over 5 employees \$100

(All Commercial permits must be renewed by July 1 each year)

### **Forty West Landfill Inbound Scale Fees**

Minimum scale fee (< 360lb MSW/<320lb Yard/<260lb Rubble/<660 Recycle) \$10

Municipal Solid Waste \$55/ton

Yard Debris (leaves, grass, brush) \$63/ton

Recycling \$30/ton

Domestic Sludge / Industrial Sludge \$60/ton

Rubble / Building Debris \$75/ton

High volume/low weight (foam, rubber, etc.) \$120/ton

Tires (auto & light truck, 5 or less)\*\* \$3 each

Tires (less than 22-inch rim size)\*\* \$162/ton

Tires (equipment)\*\* \$250/ton

Dirt (Clean Fill) \$20/ton

Carcasses (must call ½ hour before delivery) \$100/ton

Appliances containing Freon \$5 each

\*\* any customer with 6 or more tires for disposal must have a Temporary Scrap Tire Waiver from the Maryland Department of Transportation. Please call 410-537-3314 to obtain the waiver.

### **Forty West Landfill Out Bound Scale Fees**

Minimum Scale Fee (<660 lb Mulch / <1,000 lb Soil Amendment)	\$10/ton
Mulch	\$30/ton
Soil Amendment (Compost)	\$20/ton

Must have a tarp to cover all loads of mulch and soil amendment
