It is the intent of the Washington County Department of Solid Waste to provide facilities to treat, recover or dispose of solid waste in a manner that is in accordance with all applicable state, federal and local laws and regulations that relate to the protection of the air, water, land and people. While effectively integrating a system of solid waste management, waste reduction and recycling that allows the flexibility to respond to changes in regulations, technology and market conditions.

THE DEPARTMENT

The 40 West Landfill is the only open, active landfill in Washington County. We are located at 12630 Earth Care Road, approximately five miles west of Hagerstown. The 40 West Landfill opened in December of 2000 and currently has five active cells. We average approximately 550 tons of trash, yard debris and construction debris across the scales per day.

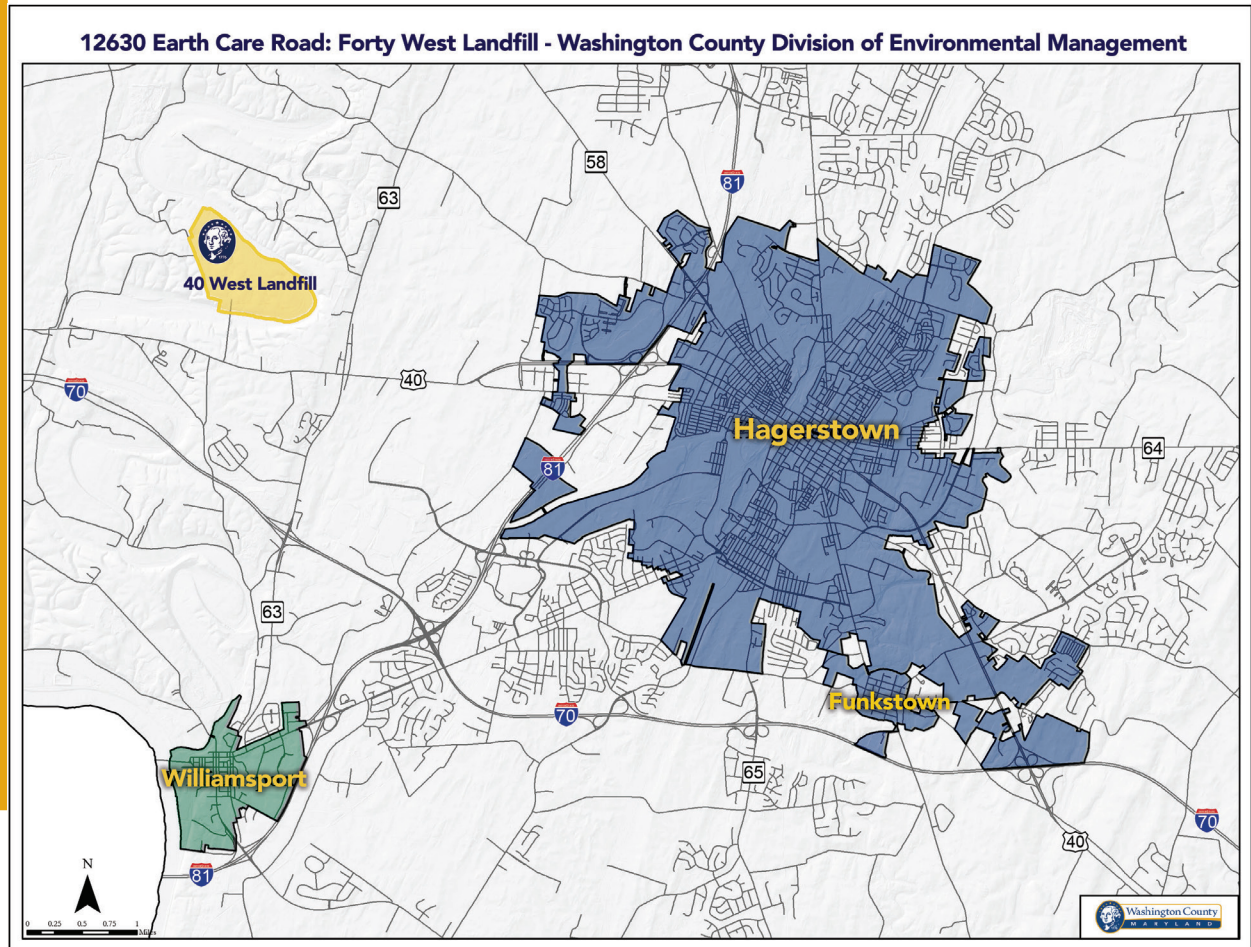
The hours of operation are Monday through Saturday, 7:00 a.m. to 3:30 p.m. Although the landfill is open on Saturdays, the main office is closed. All questions during Saturday hours can be directed to either the scale house or permit building.

Any county resident can use the landfill on a cash basis. A residential permit is not required for cash sales. We accept cash, checks, and credit cards (plus fee). Rates are \$55 per ton for general household waste, \$78 per ton for construction/demo debris, and \$63 per ton for yard debris. Other rates apply for special waste. There is a minimum scale fee of \$10. Any customer that needs to use the scales will need to be on the inbound scales by 3:00 p.m. to allow time to unload. The In-Bound Scales close at 3:00; the Out-Bound Scales close at 3:15 p.m.. Sorry but NO EXCEPTIONS. All permit customers may use the facility until 3:30. The Gates will be closed at 3:30.

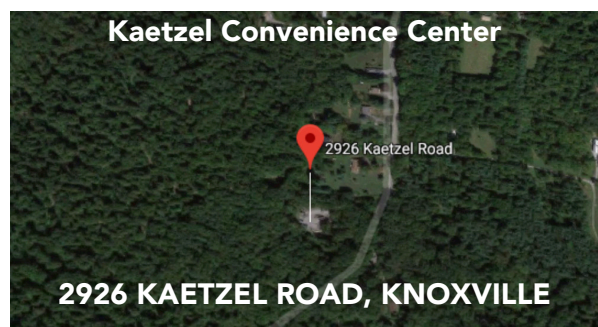

FORTY WEST LANDFILL INBOUND FEES

TRANSFER STATIONS

Washington County has four (4) Transfer Stations around the outer perimeter of the County. These facilities are by permit only; they only accept trash, recyclables, cardboard, oil and antifreeze. The addresses and hours are shown below.

PERMIT PROGRAM

The Permit Program allows residents of Washington County to pay a nominal fee to drop off general household trash from your residence only, at the 40 West Landfill or one of the Transfer Stations. Trash allowed on the permit is classified as standard kitchen and bathroom trash. Items not allowed in the permit program include construction/demolition debris, roofing materials, land clearing/yard debris, bulk items (i.e. furniture, mattresses, bedding, large area rugs and padding), brick/block, tires, appliances with refrigerant and electronics.

To apply for a permit, visit the Solid Waste Permit Sales Building at the 40 West Landfill or any of the Transfer Stations. Residential Permits may be purchased at the Forty West Landfill residential use lot between the hours of 8:00 a.m. and 2:30 p.m., Monday through Saturday. Purchases can be made by check or cash. Permits may also be purchased year-round at all of our transfer stations between the hours of 8:00 a.m. and 3:00 p.m., Tuesday through Saturday. Purchases must be made with a check only. Bring the vehicle registered in Washington County, you wish to permit so the permit can be placed on the vehicle; your Maryland Driver's License and registration are also required. The address on your license and registration must match and be located in Washington County. You may bring trash at that time for unloading after purchase of permit.

Effective July 1, 2018, yard debris will be covered under a Yard Debris permit. Additionally, use of the recycling bins and Cardboard Only recycling bins at all Convenience Centers will be covered under a \$40 Recycling Permit. Each permit is now available individually.

PERMIT APPLICATION INSTRUCTIONS

- If purchasing permit at the 40 West Landfill, you must pull into one of the two open lanes and stay in vehicle until you arrive at the Stop sign at the permit building. Complete the application that is given to you while you're waiting in line and then bring the application, driver's license, vehicle registration, and form of payment to the window to purchase your permit.
- If purchasing at a Convenience Center, pull up to the building and follow rules posted or knock on door. You will be given an application to complete. Make sure you have your driver's license, vehicle registration, and a check.
- Make your check or money order payable to Washington County Treasurer. No cash is accepted at the Convenience Centers.
- Proof of age for Senior Citizen discount will be verified by driver's license birth date.
- Verification for Disabled Veteran Permit: Copy of Veteran's Administration Service Award letter or other Government issued documentation.

In the event your permitted vehicle or trailer is sold, or windshield or bumper is replaced, please remove the sticker(s) and bring it and your permit sales receipt, the title documentation for the new vehicle and the prior vehicle registration plate surrender receipt to the 40 West Landfill for permit replacement. Replacement stickers can be issued where you purchased your original permit.

Types of Vehicles Not Permitted:

- No dump bed trucks/trailers or stake body trucks.
- No pick-ups or trailers with fixed high side racks greater than 18".
- Trailers must be no longer than 12 feet unless otherwise approved by management.
- No dual axle trailers unless approved by management.
- No Company trucks or trailers unless you are the owner of the company.
- Special exceptions may be made for citizens with disabilities

PERMIT FEES

REGULAR RESIDENTIAL PERMIT \$135

(Regular household trash typically placed at the curb for residential pickup)

SECOND RESIDENTIAL PERMIT - SAME OWNER \$67.50

(A second permit for a second vehicle, registered to the same owner, at the same address can be purchased for \$65. The vehicle must be registered to the driver to qualify.)

SENIOR RESIDENTIAL PERMIT (AGE 62+) \$98

DISABLED AMERICAN VETERAN RESIDENTIAL PERMIT \$98

(If you are a Disabled American Veteran as designated by the US Dept. of Veterans Affairs, and age 62 or under, please bring proof of VA disability at time of purchase.)

YARD DEBRIS PERMIT - PURCHASED WITH A REGULAR PERMIT \$25

(Unlimited yard debris disposal - lawn clippings, brush, branches and trunks 6" diameter from residence)

YARD DEBRIS STAND ALONE PERMIT \$50

RECYCLING PERMIT \$40

(Recycling Permits are required for use of the recycling drop boxes at the 40 West Landfill and recycling boxes and segregated cardboard bins at all center locations. Permit available to all County residents.)

RECYCLING

Currently in Washington County recycling can be done by private hauler recycling permit or crossing the scales. Private haulers will provide curb side recycling at your residence for a fee. Each hauler may have a different list of materials allowed to be placed in the bins, so be sure to understand your specific haulers program.



- Scrap metal, used motor oil (up to five gallons), used antifreeze (up to five gallons), used cooking oil (up to five gallons) can also be recycled for free at the 40 West Landfill, please see the attendant for the specific locations.
- Electronics recycling is also available for \$55/ton. Included in the Electronics Program are TV's, monitors, computers, cell phones, video games, VCR's, CD players, radios, and stereo equipment. There is a \$10 minimum charge.
- County residents and businesses whom would like to recycle but not hire a private hauler can now cross the scales and pay \$30/ton for recyclables. This option is only available at the 40 West Landfill. There is a \$10 minimum charge which covers up to 660 pounds.

Yard Waste Program

Residents can bring yard waste to the landfill with either a permit or by going across the scales. Acceptable yard waste is the plant waste derived from gardening, landscaping, and tree trimming activities, including leaves, garden waste, lawn cuttings, weeds, and prunings. We cannot accept branches over 6" in diameter. Yard debris is only acceptable for disposal at 40 West Landfill. The Yard Waste Permit, like your trash permit, only covers yard debris from your household only.

Yard waste will be ground into either mulch or compost and can be purchased by the ton by residents or businesses.

Scrap Tires

County residents can bring tires to the landfill for recycling. Individual light car and truck tires are \$3.00 each up to 5 tires, 6 or more small tires will be charged at \$250/ton. Any customer hauling six or more tires to the Landfill is required to obtain a temporary scrap tire haulers license from the Maryland Department of the Environment. Please call 410-537-3314 for the license information. There is no fee for the temporary scrap tire haulers license. We will not accept more than 50 tires from any residence or farm.

Scrap Metal

Washington County residents can drop off any metal items at No Charge at the 40 West Landfill. Scrap metal items include, but are not limited to:

Washing Machines
Dryers
Metal Fencing and Posts
Bicycles
Metal Shelving
Filing Cabinets
Lawn Mowers (all fluids removed)
Metal Furniture
Hot Water Heaters
Any other items made of at least 90% metal

Please no televisions, upholstered furniture, paint cans or soda cans. Paint cans can be disposed of with your regular trash but they MUST be empty or the paint must be completely dry. The landfill cannot accept liquids of any kind.

Refrigerators, dehumidifiers and air conditioner units must go across the scales; there is a \$5 fee for the removal of the coolant from the appliances.
