This is the site of the future home of the Washington County Public Safety Training Center. The construction company will have access to the full site and may cause damage or destroy crops. The Washington County Board of County Commissioners will not held liable for any damage or removal of crops necessary for the construction of the Washington County Training Center. The Washington County Board of County Commissioners reserves the right to approve the specific crop and location to be planted by the winning bidder.
