Questions and Response:

- Q1: John Kieffer (C. William Hetzer) When is the anticipated Notice-to-Proceed date for this project?
- R1: It is anticipated to be sometime in November/December 2019.
- Q2: John Kieffer (C. William Hetzer) Are CADD files available to the plan holders?
- **R2:** Only PDF's are available to the plan holders.
- Q3: John Kieffer (C. William Hetzer) This is a fairly complicated project. Is there any consideration to extending the question submission period and extending the bid date, by (2) weeks?
- R3: The County will review the timeline for the question/bid dates. Follow-up: The dates have been extended.
- Q4: John Kieffer (C. William Hetzer) The location for the temporary crossing in Antietam Creek doesn't appear to be in a good location for constructability purposes of the bridge.
- R4: The county will review and comment in a future addendum if necessary.

 Follow-up: The low bidder may request via MDE/Washington County to coordinate adjustments in the location/alignment if desired.
