To Vendors:

This Addendum is hereby made a part of the Request for Quotation (RFQ) Documents on which all quotations will be based and is issued to correct and/or clarify the original documents.

Please acknowledge receipt of this Addendum on the Quotation Form. This Addendum consists of five (5) pages and two (2) attachments.

NOTE: All Bidders must enter the Washington County Administration Complex through either the front door at the 100 West Washington Street entrance or through the rear entrance (w/blue canopy roof) which is handicap accessible, and must use the elevator to access the Purchasing Department to submit their proposal and/or to attend the Pre-Proposal Conference. Alternate routes are controlled by a door access system. Washington County Government has announced new security protocols being implemented at the Washington County Administration Complex at 100 West Washington Street, Hagerstown. The new measures took effect Tuesday, February 14, 2017. The general public will be subject to wand search and will be required to remove any unauthorized items from the building prior to entry. Prohibited items include, but are not limited to: Weapons of any type; Firearms, ammunition and explosive devices; Cutting instruments of any type - including knives, scissors, box cutters, work tools, knitting needles, or anything with a cutting edge, etc.; Pepper spray, mace or any other chemical defense sprays; and Illegal substances.

ITEM NO. 1: <u>Inquiry</u>: Is there a specific method of cleaning that is required? If so please describe.

<u>Response</u>: Refer to the Request for Quotation document, Page 12, Scope of Work/Specifications, Letter D., Cleaning Method.

ITEM NO. 2: *Inquiry*: How long has the current provided had the contract?

Response: The current contractor has held the contract for five (5) years.

ITEM NO. 3: <u>Inquiry</u>: Approximately how much total square footage of carpet are part of the bid?

<u>Response</u>: There is approximately 140,700 square feet of carpet included as part of the quote.

ITEM NO. 4: <u>Inquiry</u>: For the carpet cleaning will you accept the rotor brush method along with hot extraction for the aforementioned quote.

<u>Response</u>: Refer to the Request for Quotation document, Page 12, Scope of Work/Specifications, Letter D., Cleaning Method.

ITEM NO. 5: *Inquiry*: Can I be provided with a copy of the current contract?

<u>Response</u>: No formal contract is executed for this service. See Attachment "A" to this addendum to view the Award Letter.

ITEM NO. 6: *Inquiry*: What is the amount of the current contract?

Response: The current contract amount is \$10,698.00 annually.

ITEM NO. 7: *Inquiry*: Is there a grading scale when scoring the quote submittals?

<u>Response:</u> No, there is no grading scale associated with the evaluation of the quotes.

ITEM NO. 8: <u>Inquiry</u>: How and when will invoices be paid?

<u>Response</u>: Accounts payable terms are immediate upon receipt; checks are processed on Thursdays of every week and are mailed via the U.S. Postal Service.

ITEM NO. 9: *Inquiry*: Once awarded how will access to the court house be given?

Response: Carpet cleaning is conducted on weekends; County personnel will be present to grant access to all locations.

ITEM NO. 10: *Inquiry*: Will there be access to a water supply?

Response: Yes, access to a water supply will be available.

ITEM NO. 11: *Inquiry*: Is subcontracting for services allowed on this contract?

<u>Response</u>: No, subcontracting for services is not acceptable for this contract.

ITEM NO. 12: *Inquiry*: Is the moving of furniture required?

<u>Response</u>: Moving basic furniture such as chairs or small furniture may be required; County staff will remove miscellaneous items from carpeted areas prior to all scheduled cleanings. Large pieces of furniture are not required to be moved.

ITEM NO. 13: *Inquiry*: Is carpet dying allowed?

Response: No, carpet dying is not allowed.

ITEM NO. 14: <u>Inquiry</u>: Staples were present in the carpet at one location; will this be the vendor's responsibility to repair?

<u>Response:</u> The carpet at this location will be repaired before the contract is awarded.

ITEM NO. 15: <u>Inquiry</u>: Is the carpet in the buildings not included in the tour of the same grade as the buildings within the tour?

Response: Yes, the carpet is of the same commercial grade in all buildings.

ITEM NO. 16: *Inquiry*: Is the current vendor a local vendor?

Response: The current vendor's home office is located in Kensington, MD., originally quoted out of the Rockville, MD location.

ITEM NO. 17: *Inquiry*: Are there Residential properties associated to this bid?

<u>Response</u>: No, refer to the Request for Quotation document, Page 12, Scope of Work/Specifications, Letter F., Additional Services on an As-Needed Basis, item (1)a.

ITEM NO. 18: <u>Inquiry</u>: Square footage is needed for 6b on the pricing page, Agricultural Education Center Extension Office Is this included in square footage for the Ag Ed Center?

<u>Response</u>: Refer to the Request for Quotation document, Page 11, Scope of Work/Specifications, Letter B., Scope of Work, Bullet point No. 8, the Rural Heritage Museum and the University of Maryland Extension Service Office is included in 8,100 square footage.
