To Bidders:

This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Proposal Form. This Addendum consists of two (2) pages.

NOTE: All Bidders must enter the Washington County Administration Complex through either the front door at the 100 West Washington Street entrance or through the rear entrance (w/blue canopy roof) which is handicap accessible and must use the elevator to access the Purchasing Department to submit their proposal and/or to attend the Pre-Proposal Conference. Alternate routes are controlled by a door access system. Washington County Government has announced new security protocols being implemented at the Washington County Administration Complex at 100 West Washington Street, Hagerstown. The new measures took effect Tuesday, February 14, 2017. The general public will be subject to wand search and will be required to remove any unauthorized items from the building prior to entry. Prohibited items include but are not limited to: Weapons of any type; Firearms, ammunition and explosive devices; Cutting instruments of any type - including knives, scissors, box cutters, work tools, knitting needles, or anything with a cutting edge, etc.; Pepper spray, mace or any other chemical defense sprays; and Illegal substances.

**ITEM NO. 1:** <u>Inquiry</u>: We would like to request a bid extension to Monday August 5<sup>th</sup> if possible.

<u>Response</u>: All references in the bid document made to the Bid Submission Deadline and Bid Opening Time shall be changed to read: **No later than 2:00 P.M. (EDT/EST), Monday, August 5, 2019.** 

Refer to the bid document, Page 18, Supplemental Terms and Conditions Item No. 11, Late Charges; CHANGE, this paragraph to read as follows: Assessments will be made at the rate of



one (1%) percent of the bid price per consecutive calendar day if the successful Contractor fails to complete the project on or before October 22, 2019. This assessment shall be deducted from the invoice price.

ITEM NO. 2: <u>Inquiry</u>: Since there was not a complete design with engineered drawings we have had some trouble getting subcontractor coverage. We also would need to set up a site visit for an electrical contractor to investigate where power can be obtained and too see if there are any spare circuits available for the 12 total number of receptacles.

<u>Response</u>: A site visit can be arranged with prior notice, but there are currently two (2) power sources for the existing units:

- 1. Via a power pole located at the divider
- 2. Connection behind the existing panel to the left of the existing door (see below)
