This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Proposal Form. This Addendum consists of five (5) pages and two (2) attachments.

NOTE: Washington County government has limited access to the Washington County Administration Complex at 100 West Washington Street, Hagerstown, Maryland until further notice. All Bidders shall allow ample time for delivery of their bid packets. Delivery of bid packets via-courier service or United States Postal Service (USPS) will be accepted. For those bidders who wish to deliver their bid packet in person will need to call 240-313-2330 to schedule an appointment.

ITEM NO. 1 <u>Inquiry</u>: Would you like the entire proposal returned or just the pages we have entered information on?

<u>Response</u>: Bidders shall submit the Signature to Bids, the Provisions for other Agencies, the Government-Wide Debarment and Suspension pages along with the Form of Proposal as their bid submittal no later than 2:00 P.M., (EDT/EST), Wednesday, October 14, 2020.

ITEM NO. 2: <u>Inquiry:</u> Bid Item #1 Chlorine 2000# ton containers for the City of Hagerstown \*What was the actual quantity ordered or used in the past 12 months?

Response: The actual quantity ordered for FY'20 was 152,000 pounds (or 76 ton).

ITEM NO. 3: <u>Inquiry</u>: Bid Item#38 Chlorine 150#cylinders for the Town of Boonsboro \*How many chlorine cylinders per delivery?

\*What was the actual quantity ordered or used in the past 12 months?

<u>Response</u>: Part 1 of Item No. 3 herein: Ten (10) cylinders per delivery, every 2.5 months.

Part 2 of Item No. 3 herein: Forty-nine (49) cylinders were ordered in the past twelve months.

Part 3 of Item No. 3 herein: Univar is the current vendor and the awarded price is \$1.12/lb.

Part 4 of Item No. 3 herein: Yes, a lift gate is required for this location.

Part 5 of Item No 3 herein: A box truck is not required; however, the current vendor does use a box truck for delivery.

### ITEM NO. 4: <u>Inquiry</u>: Bid Item #39 Sulfur Dioxide 150#cyinders for the Town of Boonsboro

\*How many sulfur cylinders per delivery?

\*What was the actual quantity ordered or used in the past 12 months?

\*This item for Boonsboro was not on last year's bid/bid tab so can you provide who the current vendor is and price or bid tab from them for the last time it was out?

\*Is a lift gate trailer required?

\*Is a box truck required?

\*Does the sulfur dioxide ship at the same time as the chlorine?

<u>Response</u>: Part 1 of Item No. 4 herein: Ten (10) Cylinders per delivery, every 2.5 months.

Part 2 of Item No. 4 herein: Forty-nine (49) Cylinders was the quantity ordered in the past twelve months.

Part 3 of Item No. 4 herein: Univar is the current vendor and the awarded price is \$1.33/lb.

Part 4 of Item No. 4 herein: Yes, a lift gate is required for this location.

Part 5 of Item No 4 herein: A box truck is not required; however, the current vendor does use a box truck for delivery.

Part 6 of Item No. 4 herein: Yes, sulfur dioxide is to ship at the same time as the chlorine.

### ITEM NO. 5: <u>Inquiry</u>: May I please get the most recent bid tabulation for these products?

Response: See Attachment "A" to this addendum.

<sup>\*</sup>Is a box truck required?

ITEM NO. 6: <u>Inquiry</u>: Bid Item #10 Sulfuric Acid – How many drums of sulfuric acid do the Sharpsburg Water Treatment and Cascade Well House receive per delivery?

<u>Response</u>: The Sharpsburg Water Treatment location receives two (2) 55-gallon drums per delivery and there is no requirement for Item No. 10 at the Cascade Well House location.

ITEM NO. 7: <u>Inquiry</u>: Bid Item #14 Caustic Soda — Could you please provide clarification on the size of the caustic soda drums used at each location and the number of drums received per delivery per location. Sharpsburg says four but has 30 in parenthesis. Conococheague says 144 drums. If those are 55-gallon drums, that is not possible.

<u>Response</u>: Part 1 of Item No.7 herein: The Sharpsburg Water Treatment location receives three (3) 55-gallon drums per delivery.

Part 2 of Item No. 7 herein: Cascade Well House location receives five (5) 55-gallon drums per delivery.

Part 3 of Item No. 7 herein: Pennersville Well House location receives five (5) 55-gallon drums per delivery.

ITEM NO. 8: <u>Inquiry</u>: Bid Item #40 Sodium Fluoride – Are all 25 bags of sodium fluoride received in one order? If not, how many bags are received per order?

Response: Yes, twenty-five (25) bags are to be delivered in one delivery.

ITEM NO. 9: <u>Inquiry</u>: Bid Item #41 Diatomaceous Earth – Can you please provide the current product being used? There are many different grades of diatomaceous earth and additional product specifications are needed. Also, would all 50 bags be shipped at once. If not, how many are received per delivery?

<u>Response</u>: Part 1 of Item No. 9 herein: The current product being used is Diatomaceous Earth Celite 545. (Food Chemicals Codex Grade and AWWA Standard B101-16)

Part 2 of Item No. 9 herein: Yes, fifty (50) bags are to be delivered in one delivery.

ITEM NO. 10: <u>Inquiry</u>: The bid documents stated liquidated damages \$150.00/day if not delivered in 48 hours, but the under each product it states Delivery shall be within one (1) week of order. Can you advise?

<u>Response</u>: Refer to the bid document, Page 17, Supplemental Terms and Conditions, Item No. 10. Bidder(s) must have product readily available and delivered within forty-eight (48) hours (excluding Saturdays, Sundays, and County observed holidays), unless specified otherwise herein, of order request by the County. Liquidated damages in the amount of One Hundred Fifty (\$150.00) Dollars per day shall be deducted from the Bidder's invoice for each day exceeding the time period allowed that a delivery is not completed, unless stated otherwise.

ITEM NO. 11: <u>Inquiry</u>: Can you clarify the HFS. The bid states will be shipped in minibulk instead of 15 gallon pails and 55 Gallon drums. But the pricing page 16 D asks for pricing on 15 gallon pails, and there is no pricing for 55 Gallon drums for City of Hagerstown. Also, can you provide the typical delivery volume for minibulk HFS and the delivery requirements to deliver to the minibulk tank (ie: tank size, connections, metered truck etc.).

<u>Response</u>: Refer to the bid document, Page 28 Detailed Technical Specifications and Page 51, Specification and Form of Proposal. ITEM NO. 16D Hydrofluosilicic Acid (H2SiF6); **DELETE** in its entirety.

The City of Hagerstown expects to order approximately eight hundred, twenty-five (825) gallons per delivery (3 totes having 275 gallons in each of them). The current vendor had totes and a transfer pump on their truck. They pumped out of the truck and blew their lines out when they were finished. We would prefer this method going forward. The tank size is 1,550 gallons and the connection for fill line is 1 ½" female camlock.

ITEM NO. 12: Inquiry: Bid Item #15 (P. 27) The description says shall be shipped in self-unloading tank truck, but there are several references to drums in the delivery section. I just want to confirm the bid is for bulk deliveries only. Also, are any locations currently using this product?

<u>Response</u>: Refer to the bid document, Pages 27, 28 and 50, Specification and Form of Proposal. ITEM NO. 15 Ferrous Chloride Solution; **DELETE** in its entirety.

**ITEM NO. 13:** *Inquiry*: For the Bid do we have to submit bonds. This is not a construction bid so wanted to confirm.

<u>Response</u>: There are no bond requirements for this bid.

ITEM NO. 14: <u>Inquiry</u>: Regarding item # 37 Magnetite, please tell us what the minimum order quantity is. Is it 30,000 lbs.?

<u>Response</u>: The estimated minimum order quantity for item #37 Magetite per location is approximately forty thousand (40,000) lbs. for Conococheague, twenty thousand (20,000) lbs. for Winebrenner and thirty-six (36,000) lbs. for Smithsburg.

ITEM NO. 15: <u>Inquiry</u>: Do we have to provide performance bond for the bid no: PUR-1475

\*\*Response\*: See Item No. 13 in this Addendum.

ITEM NO. 16: <u>Inquiry</u>: Bid Bond: How do we calculate the value? By Annual Max or Annual Min <u>Response</u>: There are no bond requirements for this bid.
