To Bidders:

This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Proposal Form. This Addendum consists of two (2) pages.

NOTE: All Bidders must enter the Washington County Administration Complex through either the front door at the 100 West Washington Street entrance or through the rear entrance (w/blue canopy roof) which is handicap accessible and must use the elevator to access the Purchasing Department to submit their bid and/or to attend the Pre-Bid Conference. Alternate routes are controlled by a door access system. The general public will be subject to wand search and will be required to remove any unauthorized items from the building prior to entry. Prohibited items include but are not limited to: Weapons of any type; Firearms, ammunition, and explosive devices; Cutting instruments of any type - including knives, scissors, box cutters, work tools, knitting needles, or anything with a cutting edge, etc.; Pepper spray, mace or any other chemical defense sprays; and Illegal substances.

ITEM NO. 1: *Inquiry:* See p. 32 92 19-4, Section 2.3-F “FGM shall be used as necessary” Plansheets do not provide location of FGM. What requirements shall be meet to need FMG? Please provide pay item, and pay quantity.

Response: Part 1 of Item No. 1 herein: The contractor can use either erosion control matting or FGM.

Response: Part 2 of Item No. 1 herein: Payment shall be included with bid Item 4.0 Erosion and Sediment Control.

ITEM NO. 2: *Inquiry:* See p. 32 92 19-5, Section 3.4-C Please provide the moisture levels requirements to be meet for the 4-inches of saturated soil. Please provide pay

item for water.

Response: Part 1 of Item No. 2 herein: Provide moisture levels in accordance with the manufacture's recommendations.

Response: Part 2 of Item No. 2 herein: No separate pay item for water shall be provided.

ITEM NO. 3: Inquiry: Can you please clarify HDPE pipe to be used in the products line you show a N12 pipe yet in your installation you refer welded joint pipe.

Response: There are no welded joints.

ITEM NO. 4: Inquiry: The meaning of the response in Item No. 2 of addendum 6 is unclear. Is the temporary slope matting required over the entire closure capped area or just slopes 3:1 and steeper?

Response: Temporary slope matting will be required over the entire closure capped area to help establish new vegetation.
