## FUEL DISPENSING SYSTEM REPLACEMENT

To Bidders:

This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Proposal Form. This Addendum consists of two (2) pages.

NOTE: All Bidders must enter the Washington County Administration Complex through either the front door at the 100 West Washington Street entrance or through the rear entrance (w/blue canopy roof) which is handicap accessible and must use the elevator to access the Purchasing Department to submit their bid and/or to attend the Pre-Bid Conference. Alternate routes are controlled by a door access system. The general public will be subject to wand search and will be required to remove any unauthorized items from the building prior to entry. Prohibited items include but are not limited to: Weapons of any type; Firearms, ammunition and explosive devices; Cutting instruments of any type - including knives, scissors, box cutters, work tools, knitting needles, or anything with a cutting edge, etc.; Pepper spray, mace or any other chemical defense sprays; and Illegal substances.

ITEM NO. 1:

<u>Inquiry</u>: Scope of work (SOW) calls for containment sumps. There are currently pedestals in place. Please confirm if containment sumps are what is required for this project.

**Response**: No containment sumps will be required for this project.

ITEM NO. 2:

*Inquiry*: SOW calls for 2" SS flex connectors. Please confirm this is the correct size. Existing piping is 1-1/2"

<u>Response</u>: Refer to the bid document, Page 23, Specifications, Associated Equipment, Item No. 16; **CHANGE**, this sentence to read as follows: 1" dia. stainless steel flex connectors.

The diesel pump has a 1" line, the gas pump has a ¾' line. Those sizes can be kept with the new pumps.

ITEM NO. 3: <u>Inquiry</u>: The existing system already has an anti-syphon valve and a 52 valve in place. SOW calls for installation of a solenoid valve. Typically, only one of those forms is used on a suction system. A third form is redundant. Please verify you do in fact want a solenoid valve installed.

<u>Response</u>: The expectation is to have a completely functional fuel system; it is preferred that the existing components be replaced with the new pumps. If the proposed system requires valves or solenoids, those components are to be installed as appropriate.

ITEM NO. 4: <u>Inquiry</u>: Once the Fluid Secure Link is installed into the new dispensers, please confirm Washington County is responsible for the activation of the new link.

<u>Response</u>: Washington County will activate the link once the project is complete.

ITEM NO. 5: <u>Inquiry</u>: Please confirm that Washington County is responsible for the cost of the annual hosting after the initial installation of the one (1) new Fluid Secure Link. Please also confirm the cost for hosting the two existing Fluid Secure Links are not part of this SOW.

<u>Response</u>: Part 1 of Item No. 5 herein: Washington County will be responsible for all cost associate with Fluid Secure.

<u>Response</u>: Part 2 of Item No. 5 herein: The cost for hosting the links is not part of this project. Washington County will be responsible for all cost associate with Fluid Secure.

ITEM NO. 6: <u>Inquiry</u>: Page #1 material items 1 & 2 states the dispensers are to have white painted doors. Page #3 Fuel Dispensers: items #1 states the dispensers are the have 304 lockable stainless steel panels. Please confirm if we are quoting white painted or stainless-steel doors.

<u>Response</u>: Refer to the bid document, Page 25, Fuel Dispensers, Item No. 1; **CHANGE**, this section to read as follows:

Contractor shall supply and install one (1) Gasboy 9853K DF Single Suction pump and 9853K TW@ DF Dual Suction pump or approved equal electronic fuel dispensers.... lockable **white** panels, non-settable mechanical totalizers, internal hose retractors, and high hose retractor for 1 in. diesel nozzle side.
