FUEL DISPENSING SYSTEM REPLACEMENT

DATE: Monday, May 15, 2023

BIDS DUE: Wednesday, May 24, 2023

To Bidders:

This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Proposal Form. This Addendum consists of two (2) pages.

**NOTE:** All Bidders must enter the Washington County Administration Complex through either the front door at the 100 West Washington Street entrance or through the rear entrance (w/blue canopy roof) which is handicap accessible and must use the elevator to access the Purchasing Department to submit their bid and/or to attend the Pre-Bid Conference. Alternate routes are controlled by a door access system. The general public will be subject to wand search and will be required to remove any unauthorized items from the building prior to entry. Prohibited items include but are not limited to: Weapons of any type; Firearms, ammunition and explosive devices; Cutting instruments of any type - including knives, scissors, box cutters, work tools, knitting needles, or anything with a cutting edge, etc.; Pepper spray, mace or any other chemical defense sprays; and Illegal substances.

**ITEM NO. 1:** *Inquiry:* It has come to our attention that the current lead time for the Gasboy dispensers is currently 20-22 weeks from the date of approved submittals. Would the county consider the Wayne suction pump dispenser as an alternative? The current lead time on the Wayne suction pump is 6-8 weeks from the date of approved submittals.

Given this new information, will a one-week extension be considered to allow the county time to review the alternate option and for the GC to get updated pricing should the alternate be approved?


*Response:* Part 1 of Item No. 1 herein: The Wayne Fuel pumps are an acceptable alternate to the GasBoy Fuel Pump. All other requirements will be satisfied especially the interface with the FluidSecure system.

Response: Part 2 of Item No. 1 herein: All reference in the bid document made to submission deadline shall be **CHANGED**, to read **No later than 2:00 P.M., (EDT/EST), Wednesday, May 24, 2023.**

**ITEM NO. 2:** *Correction to Addendum No. 1, Item No. 6: **CHANGE**, Item No. 19 to read as follows:*

**Time of Completion:** By submission of a bid, the Bidder agrees to commence work under this Contract upon receipt of the Notice to Proceed (issuance of Purchase Order), prosecute the work diligently, and shall be complete the work no later than ninety (90) consecutive calendar days thereafter. The time stated for completion shall include material procurement, performance of the work, and final clean-up of the premises ready for use.
