To Bidders:

This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Bid Form. This Addendum consists of two (2) pages.

NOTE: All Bidders must enter the Washington County Administration Complex through either the front door at the 100 West Washington Street entrance or through the rear entrance (w/blue canopy roof) which is handicap accessible and must use the elevator to access the Purchasing Department to submit their bid and/or to attend the Pre-Bid Conference. Alternate routes are controlled by a door access system. The general public will be subject to wand search and will be required to remove any unauthorized items from the building prior to entry. Prohibited items include but are not limited to: Weapons of any type; Firearms, ammunition, and explosive devices; Cutting instruments of any type-including knives, scissors, box cutters, work tools, knitting needles, or anything with a cutting edge, etc.; Pepper spray, mace, or any other chemical defense sprays; and Illegal substances.

ITEM NO. 1: <u>Inquiry</u>: Will the project start date be pushed back to allow Camp June to close for the season in order to keep minimum flow in order to plug the uphill line.? And when does the Camp close for the season?

<u>Response</u>: Part 1 of Item No. 1 herein: Yes, this project is anticipated to begin mid to late September after Camp Louise is closed for the season.

<u>Response</u>: Part 2 of Item No. 1 herein: There is minimal activity at Camp Louise after August 30<sup>th</sup>.

ITEM NO. 2: <u>Inquiry</u>: What does the county consider to be abandoned in place for the existing manhole? Fill with stone? concrete? or to leave as is?

<u>Response</u>: Part 2 of Item No. 1 herein: Fill manhole with excess excavated material and cover with topsoil.

ITEM NO. 3: <u>Inquiry</u>: For the Winebrenner WWTP Sewer Line Relocation, is the contractor or owner responsible for providing the compaction technician for pipe bedding / bakfill?

<u>Response</u>: No compaction technician will be required; backfilling operations will be visually inspected by the County.
