To Bidders:

This Addendum is hereby made a part of the Contract Documents on which all bids will be based and is issued to correct and clarify the original documents.

Please acknowledge receipt of this Addendum at the appropriate space on the Proposal Form. This Addendum consists of Three (3) pages and two (2) attachments.

NOTE: All Bidders must enter the Washington County Administration Complex through either the front door at the 100 West Washington Street entrance or through the rear entrance (w/blue canopy roof) which is handicap accessible and must use the elevator to access the Purchasing Department to submit their bid and/or to attend the Pre-Bid Conference. Alternate routes are controlled by a door access system. The general public will be subject to wand search and will be required to remove any unauthorized items from the building prior to entry. Prohibited items include but are not limited to: Weapons of any type; Firearms, ammunition and explosive devices; Cutting instruments of any type - including knives, scissors, box cutters, work tools, knitting needles, or anything with a cutting edge, etc.; Pepper spray, mace or any other chemical defense sprays; and Illegal substances.

ITEM NO. 1: <u>Inquiry</u>: There is a quantity discrepancy in both Bid Items L-125-5.5 and L-125-5.6: Item 5.5 lists (15) on the Bid Schedule but only (14) on the Sign Schedule. Conversely Item 5.6 lists (11) on the Bid Schedule but has (12) on the Sign Schedule. I believe the issue is with sign #1 which is listed as Pay Item 5.6 on the Sign Schedule but is shown as a 2-module sign, which puts it under Pay Item 5.5.

<u>Response</u>: A "**REVISED**" Schedule of Prices Form is included as an attachment to this addendum. The revision resulted in the following changes.

Pay Items 5.5 and 5.6 both are being changed to a quantity of 13 each.

ITEM NO. 2: Inquiry: Discrepancies with Required Modules Sign 1 is listed under Pay Item L-125-5.6 (3 modules); however, the Sign Schedule indicates it is 2 modules (NOTE: Legend should be 3 modules) Signs 102, and 105 are listed under Pay Item L-125-5.5 (2 Modules). However, the Sign Schedule indicates these signs should be 3 modules (NOTE: Sign 102 legend is the same as sign 1) and Sign 105 is shown as 3 modules on the Sign Schedule

<u>Response</u>: A "**REVISED**" Schedule of Prices Form is included as an attachment to this addendum. The revision resulted in the following changes.

Signs 1 and 102 should be 3 modules as indicated and paid for under Item L-125-5.6. Sign 105 is a 2 module and the blank panels on the graphic should be ignored.
