**RECOMMENDED MOTION:** Move to award the procurement of a subscription renewal to GHA Technologies, Inc. of Scottsdale, AZ, for a Total Sum Bid Price of \$170,767.44 over a three (3) year term. Annual cost for the three (3) year term is \$56,922.48 per year.

**REPORT-IN-BRIEF:** The Pure Storage equipment forms the foundation for all County server computer resources, and is critical to the operation of all on-premise servers.

The Invitation to Bid (ITB) was advertised on the State of Maryland's "eMaryland Marketplace Advantage" website, the County's website, in the local newspaper; and on the County's new electronic bid site (Enuna/Ionwave). Fifteen (15) persons/companies registered/downloaded the bid document online and on July 16, 2025, the County accepted bids; one (1) bid was received. The Contract term shall be for a one (1) year period beginning on August 17, 2025, with an option by the County to renew for two (2) additional consecutive one (1) year periods.
